> rupees eighty paisa)from Mr. Marutiram praturi.According to SEBI  
> guidelines each and every successful allotes get warrent certificates  
> within 10 days of allotment.Since it is more than 45 days of allotment  
> and since price of shares is rising in market, we assume that company  
> has any mollest intension of not issuing our warrents as per  
> commitment made by Mr. Marutiram to us.Thats why we have no option but  
> to file FIR against Company and Directors of the company within short  
> period of time.Mr. Marutiram praturi sold these warrents to us with  
> premium of Rs 10(ten).We have paid these amount to Mr. Marutiram  
> partly by cash and remaining by cheque.As Mr. Marutiram did not have  
> any fund to get these warrents from company,we gave him fund to  
> release warrents from the company.

> any more warrents or shares to any other party and take strict legal
